Student parking on the SBHS campus is limited to to students having a valid parking permit on their automobile. Parking permits/spaces will be allotted to students on a space-available basis. **NO CHECKS** will be accepted; only **CASH OR MONEY ORDER** (payable to South Broward High School) will be accepted as payment for a parking permit. As of September 6<sup>th</sup> 2019, only vehicles with current parking permits will be allowed to enter the student parking lot. SBHS is not responsible for vehicles parked or operated on school property (SBBC Policy #5307), and certainly cannot be held responsible for vehicles parked in areas outside our campus.

## **Please read the following policies and sign below to acknowledge:**

1. Students applying for a parking permit must submit photocopies of ALL documents listed on the other side of this form.
2. In order to be eligible for parking privileges at SBHS, students must have an overall unweighted GPA of 2.0 (or higher).
3. All obligations must be paid in full before a student can apply for a parking permit/space.
4. All parking application will require 1-2 school days for processing.
5. Vehicles are to be operated in a safe and orderly manner. The speed limit on campus is 5 mph. Reckless driving can revoke your parking privilege.
6. Students may not park in the faculty lot.
7. Students may only park in the spot assigned to them. Parking permits are not transferable to another individual or vehicle.
8. All license and insurance information must be kept current; any changes in insurance must be submitted to Mrs. Lehman in room 787 (to put on record). Failure to do so may cause a loss of parking privilege.
9. All automobiles parked on the SBHS campus are subject to search (for just cause) with the driver/owner present.
10. Valuables should not be left in vehicles. **VEHICLES SHOULD REMAINED LOCKED!**
11. Loud stereos, radios, and/or faulty alarms will not be tolerated.
12. Students are not permitted to sit in vehicles during the school day. No loitering in the parking lot is permitted. Your car is not a locker; if an item is left in your vehicle, you will need administrative approval to retrieve it during the regular school day.
13. The gate of the Student Parking lot will be closed and locked at 7:40am and will remain locked throughout the school day.



**All parking rules and road regulations are strictly enforced. Again, it is a privilege to park on campus. The administrative staff has the right to remove the parking permit of any student who violates the rules stated on this contract, or for any other serious school infraction. These rules apply before, during, and after school. Violators are subject to both revocation of permit and disciplinary action. Parking permit does not include football games and after school events**
